Privacy Policy

BEEVERYCREATIVE recognizes that privacy is a fundamental human right and further recognizes the importance of privacy, security and data protection to our customers and partners. We strongly encourage you to take some time to read our Privacy Policy in full.

This Privacy Policy informs you of our privacy practices and of the choices you can make and rights you can exercise in relation to your personal data, including information that may be collected from your online activity, interactions you have with BEEVERYCREATIVE offline, such as when you engage with our customer support representatives.

See that, this Privacy Policy does not apply to third-party applications, products, services, websites or social media features that may be accessed through links we provide on our website for your convenience and information. Accessing those links will cause you to leave the BEEVERYCREATIVE Services and may result in the collection or sharing of information about you by a third-party. We do not control, endorse or make any representations about those third-party websites or their privacy practices, which may differ from ours. We encourage you to review the privacy policy of any site you interact with before allowing the collection and use of your personal data.

1. Our Privacy Principles

- We process personal data in accordance with law and with transparency and fairness to you. **Our data processing activities are conducted**: 1) with your consent; 2) in order to fulfill our obligations to you; 3) for the legitimate purposes of operating our business, advancing innovation and providing a seamless customer experience; or 4) otherwise in accordance with law.
- We will not use personal data for purposes that are incompatible with these Principles, our Privacy Policy or specific notices associated with BEEVERYCREATIVE.
- We provide you with reasonable access along with the ability to review, correct, amend or delete the personal data you have shared with us.
- We only use personal data for the purposes described at the time of collection or for additional
 compatible purposes in accordance with law. We take reasonable steps to ensure that personal data is
 accurate, complete and current and we only collect personal data which is relevant and limited to what
 is necessary for the purposes for which it is collected. We will keep personal data for no longer than is
 necessary for the purposes for which it was collected and then we will securely delete or destroy it.
- **To protect personal data** against unauthorized use or disclosure we implement strong information security controls in our own operations and offer market-leading products and solutions with high levels of data security protection.
- We acknowledge our potential liability for transfers of personal data among BEEVERYCREATIVE entities
 or to third parties. Personal data will only be shared when third parties are obligated by contract to
 provide equivalent levels of protection. BEEVERYCREATIVE is not responsible for any personal
 information you choose to share on the website.
- We are committed to resolving any concerns regarding your personal data.

- 2. Definitions of key terms. It is important that you understand some of the key terms:
- Data of a personal nature: any information relating to identifiable natural persons or enabling their identification.
- User: the owner of the data.
- Data controller: the person who determines the purposes and means of processing the user's data before obtaining their consent and who assumes the responsibility for compliance with the General Data Protection Regulation (GDPR).
- Personal data processing: the operations or technical procedures whether automated or otherwise, which enable the collection, recording, storage, use, production, modification, restriction or cancellation, transfer or communication of data.
- Consent: any freely given, unambiguous, specific and informed indication of the user's wishes, by which they consent to the processing of their data.
- Third parties: any natural or legal person who is external to BEEVERYCREATIVE and other than the user.
- Data processor: the legal person, public authority, service or other body which provides a service to the controller and processes personal data on their behalf.
- Transfer or communication of data: any revelation of data made to a third party.

3. Data controller

4. What information BEEVERYCREATIVE may collect from you and for what purpose

The personal data collected will depend on the type of interaction you have with us. In general, it will be data which you have voluntarily provided and which is characterized by having: i) a limited nature because we won't ask for more information (personal data) than is strictly necessary for the purpose indicated; ii) a specific purpose for which they are to be processed; iii) A lawful basis that allows for such processing, which may consist of your express and freely given consent, which can be revoked at any time; the execution of a contract between yourself and BEEVERYCREATIVE; and the legitimate interest of BEEVERYCREATIVE that may consist of: producing statistics to better understand your needs and provide you with a better service, as well as to adapt our products or website (among other things) to

them; Enabling the functioning of our website using technical and functional cookies and Complying with the obligations and legal requirements involving the processing of personal data.

 and detecting security threats, fraud or other criminal or malicious activity that might compromise your

We do not use your personal data for automated decision-making that could adversely affect you or have legal consequences for you.

5. International Data Transfers by BEEVERYCREATIVE

Your personal data are not transferred internationally.

6. How long do we retain your data

We retain your data for the time necessary to meet the purpose for which it was collected, taking the legitimacy of the processing into account. If the same type of personal data is used for two or more different purposes (purchase and payment/billing), we will apply the longer storage limitation period and we will only allow access to those that need it in order to carry out their duties. SO:

For purposes related to the execution of the contract for the sale or use of a product, we will retain your
personal data for as long as the contractual relationship remains valid or for as long as it is necessary to
meet our contractual obligations.

- For purposes relating to marketing activities and commercial or corporate communication, we will
 retain your data for a period of five years from the last date that we obtained your consent. If you
 revoke it, we will restrict the personal data related to these purposes so that it cannot be used and we
 will delete it.
- For purposes related to the analysis and improvement of the user experience involving the use of personal data, we will retain your data for a maximum period of five years from obtaining your consent.
- For purposes related to personnel selection processes, we will retain the personal data of the applicants for one years.
- For purposes connected with the fulfilment of our legal obligations, we will retain your data for the period specified by the specific applicable law (tax, trading, etc.) in each case.

Once the maximum storage limitation period has ended, we will delete your personal data as stipulated by the GDPR, meaning it shall be restricted, made anonymous, pseudonymised or totally erased.

7. Children's Privacy

It is evident that 3D printing has a place in schools and universities all over the world, and we are sure that the impact will be even greater in the future. However, BEEVERYCREATIVE does not knowingly collect information from children because this websites and printers are for educator. Although we cannot verify your age when you purchase our products and services, we have implemented control mechanisms in such cases, we will restrict the personal data entered by the minor until his father, mother or guardian validates registration and proceeds to finalize the purchase. We will delete any personal data entered by any minor under the age of 16 years who does not comply with this condition within a limited time period.

6. How BEEVERYCREATIVE Keeps Your Data Secure

The data security principle requires that the necessary technical and organizational measures be adopted to ensure the security of the personal data and to prevent its alteration, loss or unauthorized access and processing. BEEVERYCREATIVE have this concern about the security of your data and daily strives for it.

On the basis of the provisions of the GDPR, we have established additional measures that improve the control of the processes and the security of our privacy management model, by applying the best available practices. Your data is hosted on reliable servers and is protected by strict policies and security measures and, periodically, we submit to independent external audits to check the robustness of our management model and to explore opportunities for improvement.

7. How BEEVERYCREATIVE Shares Data

BEEVERYCREATIVE may share personal data with service providers and authorized third parties for legitimate activities and purposes (for example, those which are necessary for the operation of

processes or the provision of products and services provided by other companies, contracted by BEEVERYCREATIVE and who can assume the role of "Data processor").

However, this communication shall always be protected by the existence of a contract that regulates it

Some of these activities are:

- Technical support (aftersales) and user support;
- Operational and contractual relationship with our business partners (distributors, retailers, technical support, etc.)
- BEEVERYCREATIVE may transfer your data to third parties when it is required for the fulfilment of our legal obligations (tax, trading, etc.) or at the request of a legal authority.

On selecting the companies that provide us with these services, we have taken into account, among other factors, their compliance with the GDPR (and they are actually susceptible to be audited by our team). They carry out the processing of personal data on the basis of the indications that we specify in writing in a contract and always in accordance with the provisions of the GDPR.

8. Use of tools for automatic data collection
